ORDER

(LAND REGISTRATION AUTHORITY)

Acting on the letters of Roberto Madrigal Acopiado and Leonardo F. Arciaga, dated 19 February 2001 and 22 March 2001, respectively, requesting reconsideration of the resolution of this Authority in the above-entitled case, particularly as to the falsity of TCT No. T-408 purportedly in the name of Don Gregorio Madrigal Acopiado, and finding no cogent reason to disturb the same, this Authority hereby DENIES the motions for lack of merit.

In fact, based on the verification conducted by the Investigation Team of the Task Force Titulong Malinis on the documents submitted by the movants, the following facts were established which further affirm the findings of the Task Force on the falsity of the alleged title of Acopiado:

- In his Certification dated 27 August 2001, Atty. Antonio L. Leachon III, Register of Deeds of Rizal, denied having issued on 30 May 2000 a certified copy of "TCT No. 408" purportedly in the name of Don Gregorio Madrigal Acopiado. Hence, the signature on the name "Antonio L. Leachon III" appearing in said copy of "TCT No. 408" (which was enclosed on the letter of Mr. Arciaga) is forged.
- The fabrication of said "TCT No. 408" in the name of Don Gregorio Madrigal Acopiado, which was allegedly issued by the Rizal Register of Deeds on 7 June 1932, is affirmed by the different versions or copies of the dubious titles which Mr. Arciaga enclosed in his letter to wit: a) "TCT No. 408" in GLRO No. 41-D, Judicial Form No. 109, Revised May 1930; b) "TCT No. 408" in GLRO Form No. 41, Judicial Form 109, Revised December 1930; and c) "TCT No. 408" in Judicial Form 140, GLRO Form No. 68, Revised October 1932. The genuine TCTs issued by the Rizal Register of Deeds in June 1932 were in old judicial forms with no revision date and their title numbers consist of 5 digits, to wit: TCT No. 21904 issued on 6 June 1932; TCT No. 21905 issued on 6 June 1932; TCT No. 21906 issued on 8 June 1932; TCT No. 21901 issued on 4 June 1932; TCT No. 21903 issued on 4 June 1932; TCT No. 21917 issued on 11 June 1932; TCT No. 21927 issued on 13 June 1932; TCT No. 21932 issued in June 1932; TCT No. 21934 issued on 15 June 1932; TCT No. 21938 issued on 17 June 1932; and TCT No. 21942 issued on 18 June
