

ORDER



In this petition, intervenors Anacleto Acoplado, et al pray for the reconstitution of the decision rendered in this case on November 4, 1975 by the then presiding judge of Branch XXVIII, now this branch which was lost/destroyed on account of the conflagration that gutted the City Hall Building of Pasay City, including the court premises on January 18, 1992.

After notice and hearing, including notice to the Office of the solicitor General and the hearing held on July 4, 1997 attended by the petitioners' counsel and Solicitor Dominador Cariaso representing the government, the cause of reconstitution was established including a confirmation by the latter that the copy of the decision attached to the record was received by the OSG thereby authenticating the same to be a faithful copy. Furthermore, the government interposed no objection to the reconstitution thereof.
