- 2. Manifestation and Motion filed by petitioner alleging that the NBI Report is less than thorough and conclusive as it did not mention the date and place of birth of Julian Morden Tatlano, the names of his parents and siblings, his address, his status, the names of his children, if any, and

Petitioner thus prayed that the NB1 be directed to make a thorough and conclusive inquiry as to the real identity or existence of the individual representing himself as Julian M. Tallano (JMT) and that the pre-trial scheduled on September 7, 2005 be held in abeyance pending submission by the NBI of *its* exhaustive and conclusive report;

- 3. Motion to elevate records in respondent court; and
- 4. Request for issuance of subpoena *ad testijIcandum* and subpoena *duces tecuni*.

We shall resolve the same in seriatim.

- 1.Petitioner is directed to comment on the motion to intervene within ten (10) days from notice.
- 2. The NB1 Report is accompanied by the Final Report, together with annexes, (*Rollo*, pp. 5069-5240) submitted by SA Florencio C. Canlas which covered the queries posed by petitioner. In view thereof, the Division Clerk of Court is directed 10 furnish petitioner with a copy of the Final Report and annexes.
